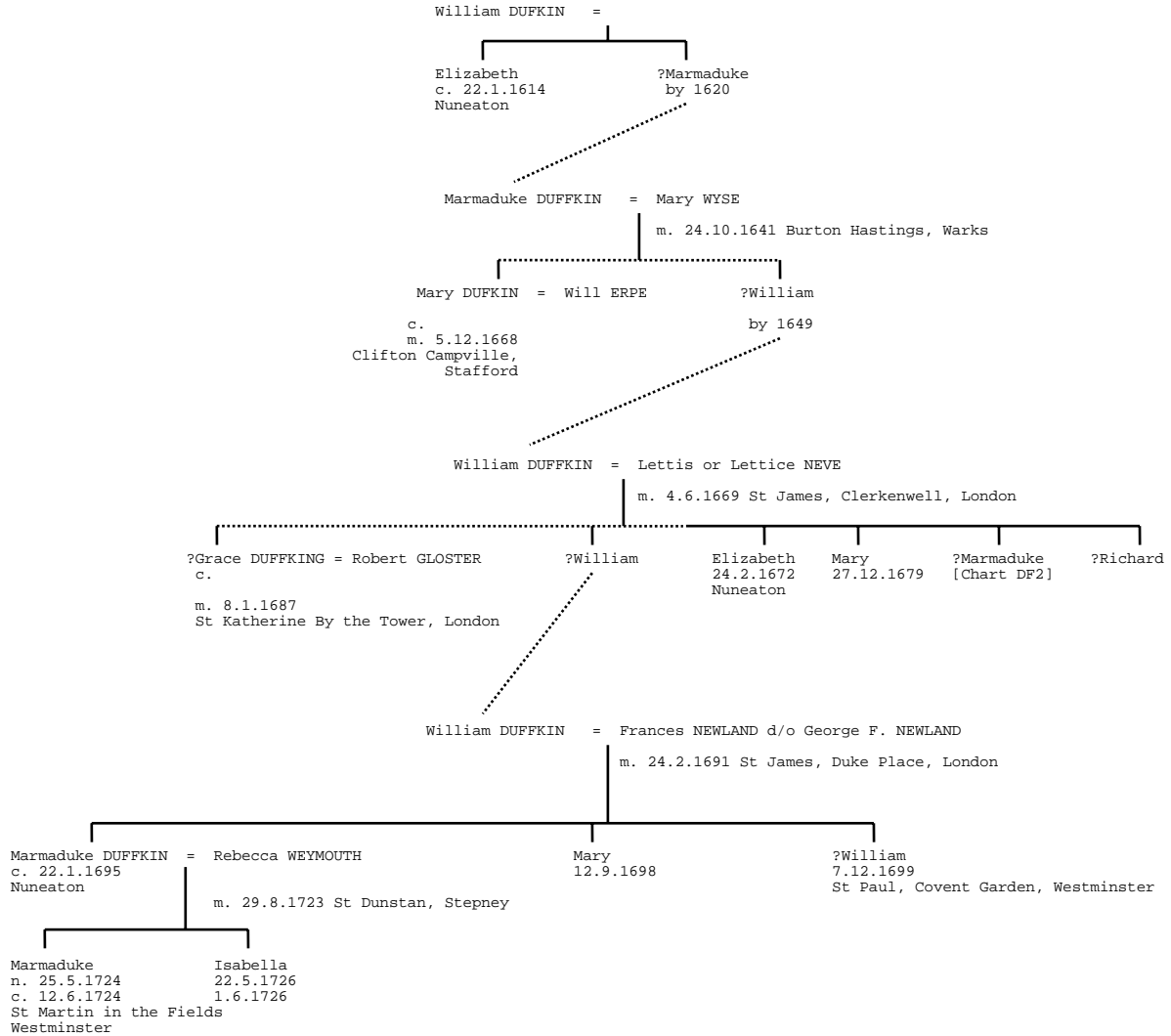


DUFFKIN/DUFKIN Family of Nuneaton & Coventry (also London & Leicester)

Family mentioned in a C16th survey of Nuneaton
 Obvious connections with London
 Spelling variants include: DUFKIN, DUFFKIN, DUFFKING, DURKIN, possibly LURKIN

Origins of DUFFKIN/DUFKIN name uncertain. Certainly part of the cloth trade in Warwickshire, with obvious merchant trade connections to London.

Marmaduke DUFFKIN:

Treasury Chambers, Whitehall, London,
Jan. 23, 1697
afternoon. Present: all my Lords.

Counsel are heard for and against Mr. Newsham, Receiver of Taxes for Warwickshire upon the complaint of Sir Richard Nudigate. The articles against him are read. To prove the second article there are read the affidavits of John Parker, the certificate of Edward Owen, mayor of Coventry. **Marmaduke Duffkin** says he was a collector in 1695 and he paid the fourth quarter to Mr. Grascomb when Mr. Newsham was in the room. He says he paid good money and he saw John Mitchener, the Receiver-[General's] man take out a very good half-crown and put another in stead of it. The counsel for the Receiver own that Grascomb was employed some little time.

To prove the 3rd Article Capt. Bagshaw says the Receiver-[General] with his brother, son and cousin have several times met privately and altered the assessments after [they had been] settled by the [Assessment] Commissioners and he instances in an assessment made 14 March, 1692-3, for [the parish of] Moreton Morrell (now produced). He being asked whether the Receiver was not indicted for this answers yes, but was acquitted.

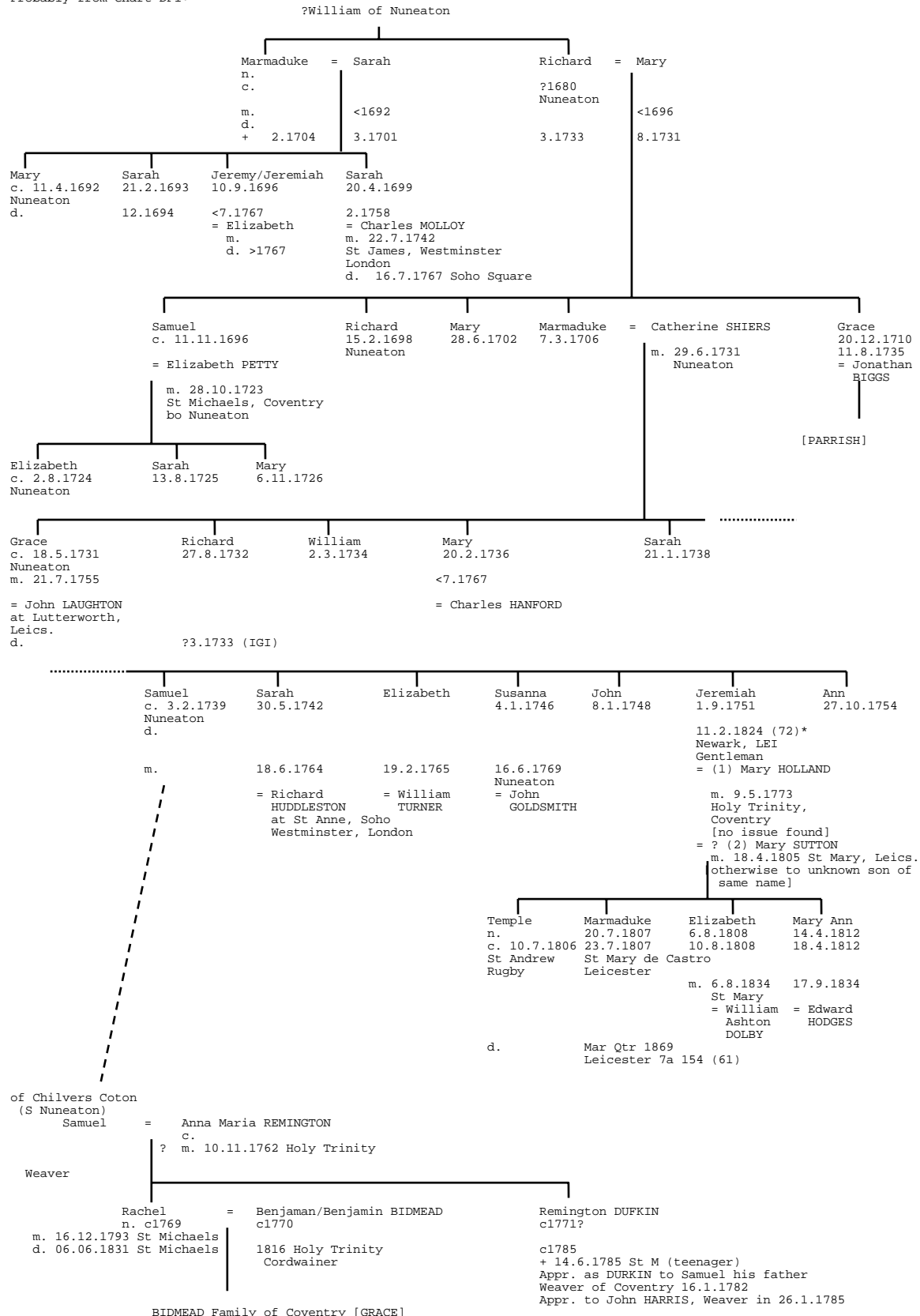
To prove the 6th and 7th articles they read the affidavits of William Vinson, John Evetts and William Knight, Henry Mathews, Martin Bayly. Mr. Parker says he saw the money Mr. Newsham brought to the Exchequer. A great deal of it was good money but some was very bad, plated, counterfeited and much clipt. Duffkin says he saw Grascomb shew several pieces of bad money which he said were refused and cut at the Exchequer. Mr. Newsham says he employed Grascombe 11 days only in the end of January and beginning of February and it was on occasion of the Proclamation requiring only sterling money and he never saw or knew him before. He heard afterwards Grascome bought up clipt money and he endeavoured to apprehend him for it. Mr. Solicitor-[General] says they have proved by affidavits that the Receiver refused clipt money before the 4th of May, [1696]. Mr. Copson a collector for Weddington says in 1694 Mr. Newsham ordered his man to alter the collector's warrant at the second payment to make him pay 7 or 8 days before the Commissioners ordered it; he carried his money to Coleshill but the Receiver was not there to have it; and afterwards he sent his man who received it and gave acquittance but would have the poundage because he came to fetch the money; and afterwards he made another payment and had an acquittance and 10 days after the Receiver sent a warrant for him to come before the Commissioners for not paying the money: he owns he received his poundage at all other times. Mr. Blow says he sent the warrant by Mr. Newsham's order.

At Edmonton Parish Church, Middlesex:

On the pavement within the chancel -

"Here lyeth the Body of Mr. JEREMIAH DUFFKIN late of this parish, Yeoman, who departed this life, Aug. ye 8th, 1751, Aged 56 Years. Also the Body of ELIZABETH his wife, who departed this life July 9th 1772, Aged 72 years."

On the pavement within the chancel, near the rails of the communion table -

"Sarah the Wife of Jarles Molloy, Esq. Departed this life January the 3rd, 1758, in ye 57th year of her age."
Charles MOLLOY was bequeathed £100 in the 1741 Will of Thomas Barber, below.

Affidavit of Basil Goode, Olton Cottage, Solihull, esq., as to the identities of Richard Holland, Coventry, watchmaker, deceased, and his three children, viz. Elizabeth, wife of Thomas Eaves, late of Stony Stratford, Bucks., yeoman; Mary, late wife (d. Nov 1808) of **Jeremiah Duffkin** formerly of Coventry, silkman, late of Leicester, gent., and Esther, deceased, formerly wife of the said Basil.

In "Works of Alexander POPE" (1967), page 489:

"...for I just received a letter from Mrs. DUFFKIN, Alderman Barber's relict, that she was ready to pay me his legacy if I would wait on her. This I cannot now do....." POPE was bequeathed £100.

Equitable deposit of deeds 23rd June, 1859:

Sir J C Thorold to Marmaduke DUFFKIN of the town of Leicester, esq., Thomas Clavert Beasley of Barston, county Leicester, esq., and Edward Hodges of the City of Bath, M.D.

Bond in £1,800 of the same date, signed and sealed by Sir J C Thorold of Syston Park to same three gentlemen.

Extracts from "An Impartial History of the Life, Character, Amours, Travels, and Transactions of Mr. John Barber, City printer, Common-Councilman, Alderman, and Lord Mayor of London" written by "Several Hands. London: Printed for E. Curll, at Pope's Head, in Rose Street, Covent-Garden, 1741. price 2s. 6d." :

Book includes the "true copy" of the John Barber's Will dated 28.12.1740, proved 21.5.1741. he died aged 66 five days after the Will was signed.

Bequests to Thomas BOWDLER Esq., late of London, Banker, Robert BARBER of the Inner-Temple, London, Esq., and Mistress Sarah DUFFKIN, spinster. Appointed Executors and paid £200 each.

After bequests "all the Rest, Residue, and remainder of my real and personal Estate, of whatever Nature or Kind the same shall be, I give, devise & bequeath to the said Sarah DUFFKIN, her Heirs, etc... as a reward for her long and faithful Services; and extraordinary Care of me for upwards of twenty years"

"To Mr. Jeremiah DUFFKIN £100" (noted as brother to Sarah DUFFKIN).
"To the Charity-School of Castle-Baynard, in the City of London, £50"

Note: The following names were not found in the Wills of Sarah MOLLOY (7.1.1756) or Charles MOLLOY (3.7.1767):

Marmaduke & Sarah, Richard & Mary, Richard, Grace & Mary (children of Richard & Mary), Elizabeth w/o Samuel and their children, Sarah & Mary (children of Marmaduke & Sarah), and Sarah, Samuel & Ann (children of Marmaduke & Catherine).

It is uncertain why Samuel was not included, either because their Samuel died or therefore is not my Samuel, or that Samuel was already well established elsewhere. The REMINGTON family are reported to be relatively wealthy, so it is possible Samuel had married into money. No registered people of this name in BMD from 1837. Extinct?

Unknown connection:

Alfred Baynard DUFKIN, MD, Professor of Pathological Anatomy in King's College, London in 1874, and published in British Medical Journal of 1879. (Note bequest in will of 1741 by John Barber as possible origin of middle name).

Mrs. DUFFKIN of Rugby: reported died by the bursting of a blood vessel in Monthly Magazine 1.9.1802
Same lady also noted as a subscriber to "The Death of Amnon" by Elizabeth Hands.

Pugh JOHN, nephew of Jeremiah DUFFKIN, Rugby aged 11 entered Rugby School at Midsummer in 1802
